




This is the committee that really fits my background and interest. For the last 28 years, my life has been centered on budgeting and fiscal affairs. I earned my MBA with a concentration in Finance from the University of North Carolina at Chapel Hill in 1983. From there I went to work for USAir. My first position there was in the Budget Department as a Financial Analyst. I managed about half of the company's budget, including fuel, space rental, landing fees, marketing, and G&A fees. From there I moved into Supervisory position in Accounting where I ensured that our cash accounts were balanced. I was then promoted to the Treasury Department where I managed the daily debt payments and investment allocations. I was also responsible for creating daily, weekly, and monthly cash flows in this position.

In 1989, I moved to the Pittsburgh office and took responsibility for fiscal affairs for the Reservations Division, ultimately becoming the Controller of the Division. In 1995 I became the Director of Administration for the Reservations Division. In this position I was responsible for all of our facilities, the staffing of these facilities, and for managing all associated costs.

After getting married in 1997, I returned to Virginia and began work in Alexandria at a Health Care consulting company called PAREXEL. I started there as the Project Controller for the largest Osteoperosis clinical trial in history. Shortly after that project ended I took over operational responsibility of the office. This responsibility included among other things, budgeting, forecasting, pricing, and high level sales presentations.

In 2004, a subsidiary of Wellpoint asked me to set up a similar operation for them in Delaware. This gave me an opportunity to build a department from scratch - a job I relished. After successfully building the department, I returned to Alexandria 2 years later to spend more time with my family. I have since worked as a consultant and project manager for large financial companies - the 2 most recent being VISA and Freddie Mac.

As you can see, I have a very strong finance background which I believe would prove beneficial for this committee. I am eager to use my knowledge and experience to help my hometown during these difficult financial times.


