PROPOSED RESOLUTION REQUESTING THE RECENTLY APPOINTED

REGULATOR FOR FANNIE MAE AND FREDDIE MAC TO MAINTAIN A

CHARITABLE GIVING PROGRAM AS PART OF ANY FUTURE

RESTRUCTURING OF THESE ORGANIZATIONS

<u>ISSUE</u>: Consideration of a proposed resolution requesting Fannie Mae and Freddie Mac to maintain a charitable giving program as part of any future restructuring of these organizations.

### **RECOMMENDATION:** That City Council:

- (1) Adopt the attached resolution joining the efforts of the Metropolitan Washington Council of Governments (COG); and
- (2) Submit copies of the resolution to the Federal Housing Agency, the National Capital Region Congressional delegation; relevant Congressional committees, and the Board Chairs of Fannie Mae and Freddie Mac.

**<u>DISCUSSION</u>**: Several Council members have asked that staff docket the attached resolution for City Council consideration. In September 2008, federal regulators placed Fannie Mae and Freddie Mac into conservatorship, and a restructuring of these organizations has been initiated in an effort to stabilize the national housing market. The Human Service Committee of the Metropolitan Washington Council of Government, at its September 25, 2008 meeting endorsed a related resolution, and encouraged the membership to adopt a similar position for communication to the recently appointed Fannie Mae and Freddie Mac federal regulator and Members of Congress.

Fannie Mae and Freddie Mac foundations have for more than a decade invested significantly in the programs and services of several of the City's nonprofit agencies. These agencies, many that are also Alexandria Fund for Human Services grant recipients, have worked in partnership with the City to address unmet needs not just limited to the areas of early childhood development, healthy birth outcomes, preventive health care, homelessness and teen pregnancy prevention. The City of Alexandria is aware of at least 10 local nonprofit agencies that currently have grant

requests pending with Fannie Mae and Freddie Mac. The amount of these requests total more than \$900,000. The Alexandria Council of Human Service Organizations is also hosting a brown bag discussion on October 28, 2008 to strategize ways to ameliorate local impacts.


