

I do not think there is any point in continuing to be a member of the WWB Neighborhood Task Force, certainly not after witnessing your entire lack of support for the Cecchis' IDI Group Plan today, and by extension, your entire lack of support for Hunting Towers residents.

I remember when you first came to visit Hunting Towers after VDOT took us over. You arrived in May 2002, shortly before you launched your mayoral campaign.

All through these many years, you always told me that you would help us preserve Hunting Towers as affordable workforce and retiree housing.

Yet by your vote earlier today, you have failed us completely, and I cannot risk
