Mayor Euille, Vice Mayor Donley, and Members of the City Council:

I am Fran Becker, the Executive Director of Carpenter's Homeless Shelter for the last twelve years.

Carpenter's mission is to end and prevent homelessness in the City. We believe that all City citizens are entitled to safe, affordable housing. We fully support Goal Seven of the Council's proposed strategic plan which calls for Alexandria being that Caring Community that is Affordable and Diverse With a Rich History and Culture.

The need for more affordable housing in our City is a long standing concern that has gained much attention. I remember testifying in the early 2000s about dire need for MORE affordable housing units, I remember when the penny fund was truly a penny and was going to help create new units and not servicing debt only.

While the issue has been given much attention and discussion, in this decade, Alexandria has been losing ground maintaining the existing stock of affordable housing. There has been indeed a "net" loss noted last year by the Council appointed Affordable Housing Work Group.

In its interim recommendations to City Council in April 2008, the Group stated, "The loss of affordable housing that has occurred in the last decade is a clear and present threat to the City's economic and racial/ethnic diversity.

Between 2000 and 2008, the City lost more than **10,000** nonsubsidized affordable rental housing units because of increases in rents. The Group further predicted that over the next five years, another 1,000 non-Resolution 830 publicly-assisted units face potential loss of subsidy. No wonder emergency shelters, like Carpenter's, are full.

I ask you, where is the Alexandria that is Affordable and Diverse???

The proposed cuts to housing funds in the FY11 budget will only increase this "clear and present threat to the City's economic racial/ethnic diversity." The proposed \$686,849 cut in housing funds is an almost a 30 percent reduction relative to FY10. The largest item proposed for reduction is the \$502,060 of the real estate tax dedicated for affordable housing initiatives.

I applaud the initiation of the City's Housing Master Plan process and its efforts to address current affordable housing in Alexandria. The proposed cuts, however, will further reduce affordable housing options that might be identified in this Master Plan.

Herb is right - these proposed cuts will, for all practical purposes, stop the conversation before it begins.

Council members, please restore the half a million dollars taken from the real estate tax revenue and put it back for affordable housing initiatives and not merely debt service.

Make Alexandria that rich, diverse, affordable and caring community that we all talk about, at least on paper. We can't afford to lose any more affordable housing...or we need to start thinking about building more emergency shelters.

The Wellness Center Statement

13 March 2010

As the person on the front line of health for nearly 2300 students every day, I am thrilled at the prospect of having The Teen Wellness Center in my hallway. Having the resource of the wellness center in our building will greatly enhance the health and well being of our students and give us unique opportunities to work collaboratively. Some of the major health needs that I see on a daily basis in the School Health Office include vision problems and the need for glasses, poor dentition, mental health issues such as depression and obesity, counseling for sexual behaviors and unplanned pregnancies, the need for health insurance to secure medical services, and of course all kinds of first aid.

Currently, students frequently need to go to the teen clinic (as it is called today). Because we are a closed campus, students may not leave the building during the school day unless they are 18 years old or they have a written note from a parent or guardian.

Recently, one student presented to me with a shingles infection and needed treatment. Because of the nature of this virus, treatment must be started within 24 hours to achieve the best outcome and limit the potential of pain duration for up to 3 months. Thankfully, this student was 18 years od and could walk there. She did, however, miss about 1 ½ hours of class. Had the we mess center been within the building, she would have lost much less instructional time.

I am also aware of student who cut whole days of school in order to be able to access the teen clinic services.

Another barrier to seeking services at the teen clinic is parental expectation for students after school. Some parents require their teenager to come directly home after school each day, thinking that this action will inhibit their child from engaging in risky adolescent behaviors. The reality is that adolescents inherently test the boundaries of behavior, and sometimes get into trouble Accessing the physical and mental health care services at The Teen Wellness Center will help to address some of these risky behaviors before they become serious problems.

Immunizations are also an enormous issue here as we continue to enroll immigrants and foreign exchange students. Following the requirements from both the health department and the school board, students generally have three visits in which to receive a complete set of vaccinations. Often times, students will miss whole days in order to get their shots.

When the wellness center is located within TCW, they will be able to get their vaccines during lunch and not miss valuable instruction time.

Finally, I would like to offer thoughts with regard to Fathers Kleinmann and Cregan's thoughts in this week's G zette Packet. I agree with the fact that high school teenagers shouldn't be having sex, and I agree that single teen mothers are not a family. Because we understand that teens can make poor judgments at times that get them into trouble, I believe, too, that having a wellness center in the high school building brakes down barriers to their getting counseling before poor decisions are made. I want to prevent teen pregnancy with all my heart.

I am sorry that I could not attend today to offer this in person, but I work as a Pediatric Nurse Practitioner at Virginia Pediatric Group, LTD. in Fairfax. It is my second job on Saturdays.

Thank you so much for supporting the creation of The Teen Wellness Center at TC Williams. I am proud to be part of a school system that values the role of health in educating the whole child.

Dear Mayor Euille and City Council Members:

The members of the Historic Alexandria Resources Commission recognize the budgetary constraints conferred upon the City due to the recession, in considering the FY 2011 budget. However, it is important to note the significant impact of the proposed reduction to the Office of Historic Alexandria. If the budget is adopted, the Office of Historic Alexandria will experience a 20% overall general fund reduction since 2007.

The Council and citizens of Alexandria have made a long-term commitment to maintaining the City's historic sites and to promotion of the City's history in attracting visitors and benefiting those of us who live in Alexandria. Further cuts in the budget of OHA place in jeopardy the investment already made in preservation of Alexandria's rich history, our ability to reward visitors with a positive and enlightening experience in our City, and our future status as one of the country's most attractive historic destinations.

The proposed budget will affect the ability of the Office of Historic Alexandria to carry out its mission for the staff. Clearly, the proposed reduction in resources hazards the ability of OHA to accomplish these planned activities, not to mention its ability to deal with unpredictable issues that arise.

- The self-study leading to accreditation of the City-owned museums by the American Association of the Sollo. This year marks the first time that OHA will apply for accreditation (which is attained by only a small percent of museums in the nation) as a whole for all OHA museums.
- The Sesquicentennial of the Civil War, a 4-year commemoration, will begin in May 2011, requiring much preparation. The benefits to the City are enormous with regard to increased tourism and revenue, prestige and reputation, and educational and participatory opportunities for diverse citizens of all ages
- of all ages.

 The Contraband and Freedmen's Cemetery design will be implemented. This is a culmination of years of archaeology, research and citizen involvement.
- The Alexandria Ad Hoc Fort Ward Park and Museum Area Stakeholder Advisory Group will make recommendations about future management direction at Fort Ward Park.
- The Alexandria Waterfront Plan will be unveiled in April 2010, followed by continued input and direction by OHA to interpret and preserve the history of Alexandria's greatest asset.

In addition, the reduction in staff means fewer hours of operation, less research, no new exhibits, a decrease in school programs for our children, and a reduction in revenue from rental of the sites. While volunteers provide more than \$500,000 to the City in hours donated, additional volunteers cannot be used at our OHA sites without staff to supervise these generous citizens. We applaud the stellar and dedicated OHA staff who continue to devote themselves to the history of our City and to our museums.

The Historic Alexandria Resources Commission requests your reconsideration of the proposed reductions to the OHA budget that will have significant negative economic, cultural, and quality-of-life implications.

Our diversity, and what makes us special, is because of this history – not despite it. It remains who we are as Alexandrians and as Americans

Alexandria's historic fabric is thus also the basis for the high value of much of it real estate – both residential and commercial, and hence part of what supports the city.

The budget for the Office of Historic Alexandria (OHA) is already inadequate to sustain its current missions, and place programs, from preservation to interpretation to tourism, all central to community identity, and putting our "brand" in

crisis. OHA cannot staff and run facilities such as Fort Ward and the Black
History Museum with two people, even with many (unprofessional) volunteers.

While private funds already help support historic properties in the city that are open to the public, such as Carlyle House, the Athenaeum, the Lee-Fendall House, and Freedom House, the record, ability, and willingness of private sources to maintain historic properties is not good. In fact, the lack of such sources locally was the reason the city took over the properties it now has, and in some cases unique resources have been lost to the public, such as Lee's boyhood home, and the tall ship Alexandria. The latter - itself a symbol of Alexandria could not be maintained by private funds, was sold, and now lies at the bottom of the sea. Until a high-profile, full time fundraising campaign with a national reach can be organized and implemented, and one fully embracing all of Alexandria's historic resources, private funding sources are not a practical or realistic approach to protecting the source of Alexandria's identity.

We do have additional options. One the Council should look at seriously is a small tax on food, beverages, and hotel rooms beyond the current level. An advantage to this approach is that it can be specified to support the City's key historic programs while it would be levied primarily on visitors, not residents, and allows them to help pay for properties to which admission is free. Such a tax would not be large enough to discourage visitors or to discourage those here from eating and drinking here. This innovation could also help support an initial campaign

for Alexandria's commemoration of the 150th anniversary of the Civil

War.

Historic Alexandria, the essence of what set our city apart, is in

jeopardy. Our city has a special responsibility for stewardship for

irreplaceable resources. Please do not allow Alexandria's historic

properties and programs to sink. Once lost, these treasures cannot be

retrieved – a loss to the community, the region, the nation, and future

generations of Alexandrians and Americans. OHA, and the City's pioneering

Archaeology programs, created by the vision of the City, are at risk and

- * attend and providing support for history-related city meetings on subjects such as the Waterfront Plan, small area plans, environmental sustainability,
- * promotion of archaeology programs press releases, flyers, mailings
- * finding, training, and supervising volunteers, supporting FOAA
- * basic office administration purchasing orders, personnel papers, budget preparation, etc.

At a minimum, the positions of people lost through retirement must be filled if Archaeology is to fulfill its mission for the City and the community.

One approach to addressing these financial problems has been to seek outside and private funds to help support cannot sustain historic properties and programs. Even in the best of economic times, this has proven difficult. While private funds already help support historic properties in the city that are open to the public, such as Carlyle House, the Athenaeum, the Lee-Fendall House, and Freedom House, the record, ability, and willingness of private sources to maintain historic properties is not good. In fact, the lack of such sources locally was the reason the city took over the properties it now has, and in some cases unique resources have been lost to the public, such as Lee's boyhood home, and the tall ship Alexandria. The latter – itself a symbol of Alexandria – could not be maintained by private funds, was sold, and now lies at the bottom of the sea. Until a high-profile, full time fundraising campaign with a national reach can be organized and implemented, and one fully embracing all of Alexandria's historic resources, private funding sources are not a practical or realistic approach to protecting the source of Alexandria's identity.

We do have additional options. One the Council should look at seriously is a small tax on food, beverages, and hotel rooms beyond the current level. An advantage to this approach is that it can be specified to support the City's key historic programs while it would be levied primarily on visitors, not residents, and allows them to help pay for properties to which admission is free. Such a tax would not be large enough to discourage visitors or to discourage those here from eating and drinking here. This innovation could also help support an initial campaign for Alexandria's commemoration of the 150th anniversary of the Civil War.

Historic Alexandria, the essence of what set our city apart, is in jeopardy. Our city has a special responsibility for stewardship for irreplaceable resources. Please do not allow Alexandria's historic properties and programs to sink. Once lost, these treasures cannot be retrieved – a loss to the community, the region, the nation, and future generations of Alexandrians and Americans. OHA, and the City's pioneering Archaeology programs, created by the vision of the City, are at risk and must be budgeted adequately, even to ensure their survival until better economic times.

Hon. Mayor and City Council,

I am writing to urge that the budget cuts for

Ft. Ward, as proposed in the City budget for FY 2011, not be implemented, and that proposed cut of \$11,000 in operating funds for Ft. Ward from City internal operating accounts be restored. The staff of Ft. Ward has already undergone significant reduction, and if the current budget proposals are enacted, I am concerned that it would mean, among other things:

- Reduced levels of public programming and interpretive activities;
- Reduced levels of collections care and exhibit development;
- Neglect of maintenance and preservation in the historic site;
- Excessive duties for the remaining staff—the Museum Director and Assistant Director/Curator.

Comments:

I would also note that the beginning of the

Civil War Sesquicentennial, with which the City of Alexandria in general, and Ft. Ward in particular, will impose additional duties. For all these reasons, I urge that the additional budget cuts proposed for Ft. Ward not be implemented.

I understand that these are difficult financial times for the City government, and that to govern is to choose; many of the choices are between bad and worse. If it proves impossible to restore the proposed cuts in funding at Ft. Ward, I suggest that the 20-hour per week Museum Technician position at the Ft. Ward Museum position be left as "unfunded," rather than totally eliminated, thus at least making the restoration of funding easier when the financial position of the City improves.

Ladies and Gentlemen:

My thanks to the Council and to Elaine Scott for including the many actual City Government email addresses in her response to my concerns about the problems of webpage email as a vehicle for means of communication from individual citizens to the appropriate persons within the City of Alexandria Government. I will be sharing this set of email addresses with other citizens, so that they will be able to communicate more efficiently with you all.

Now that I have these email addresses I can ask the Council members and the City Manager some questions about the status of the Alexandria City School Budget.

What follows is my extract of some budget numbers from the current School Board report. I am also including an article by Patrick Welsh, a member of the faculty at T.C. Williams High School, which appeared recently in The Washington Post. The Welsh article should be of concern to the Council as it considers the present and future budgets for the City School System.

My immediate questions for the Council concern the amount of money that the Federal Government contributes to the City School Budget. It appears to be a pittance.

The table below, also attached as an Excel spreadsheet, shows that the Federal Government contribution is on the order of 0.03 percent of the over \$200 million dollar school budget.

Perhaps there are additional Federal funds buried in the amount that is shown as the Virginia Commonwealth ("State") contribution; if so we should all be made aware of that sum. If there are no other Federal funds, or only a very small additional amount buried in the Virginia Commonwealth money that is provided to the City School system, then my first question would be what unfunded mandates are imposed by the Federal Government in exchange for their pittance? My second question would be how much less we would be forced to spend if we were to forego any "Federal Largess"?

Thank you for your service to the City, and thank you for your time to review these questions.

At T.C. Williams High School, a 'low achieving' label is a wake-up call

Things around T.C. Williams High School in Alexandria, where I teach English, have gotten pretty gloomy.

Two weeks ago, Superintendent Morton Sherman called an emergency faculty meeting. We gathered in the school auditorium to hear him break the news: Ours was officially a "persistently low achieving" school. That unflattering label is a new one, created by state officials and Education Secretary Arne Duncan for high schools ranked in the lowest 5 percent of schools statewide with demographics similar to ours.

I was stunned. Some of my seniors from last year went on to Yale, MIT, the University of Chicago and other great schools. Just that morning I had listened to my current seniors discuss Cormac McCarthy's "All the Pretty Horses," a novel that is hardly fare for underachievers. How dare some bureaucrats tag us with such a demeaning label?

Yet I couldn't hide from the facts: Based on students' scores over the past two years on the Virginia Standards of Learning tests, T.C. was ranked 122 of the 128 high schools in the state that serve a number of at-risk students but do not accept federal Title I resources. "Persistently low achieving" wasn't just another education cliche. Our scores didn't lie.

Things only got worse when Sherman told the teachers that we had four options for corrective action, three of which would probably involve firing at least half of us.

From that afternoon on, low-grade paranoia filled the school. We weren't just afraid of losing our jobs; the way we thought about T.C. had changed. Math teacher Gary Thomas got a call from his brother-in-law asking what it was like to teach at one of "the worst schools in the nation." Thomas is a West Point graduate and retired Army colonel who usually can be found in his classroom an hour before and an hour after school, tutoring kids. "You feel horrible when you are putting in the time and effort and see a lot of your students who catch on and do well get characterized as low achievers," he told me.

How did our school -- which in 1984 received one of the country's first Department of Education excellence awards and in 1988 had the highest number of National Merit semifinalists in the state -- get to this point?

T.C. Williams has always been proud of its student achievement and its diverse community. But as the demographics of the school shifted over the past 25 years and low-income students -- many of them minorities and immigrants -- began to outnumber middle-class kids, one thing that didn't change was the way the school thought about its students. Even though we knew better, many of us -- both teachers and administrators -- acted as if all our students came to school with basic reading and math skills and had a parent at home actively supervising their education. The stragglers could do the work, we insisted, if they were in a room full of other kids who could do the work, too. The school definitely did not want to create tracking classes, in which kids are separated according to ability, or anything that could resemble ethnic or class-based segregation.

Instead of zeroing in on the relatively small number of students who came to us unprepared and needed a great deal of help to catch up, we opted for appearances. The school mixed kids of different academic levels into the same classes in hopes that the best students would pull up those on the bottom. We also continued passing kids through the system, whether they had learned the skills they needed or not. Gary Thomas says many students enter T.C. Williams not knowing how to add or subtract without a calculator, and even the better students do not understand fractions.

We tried to confront some of these challenges once before. But in 1997 the school board rejected a task force recommendation that Alexandria create an alternative school -- the type of school that we desperately need today to serve students with specific educational challenges. Glenn Hopkins, who runs a nationally recognized local preschool program, remembers that fight. He said he and other task force members were "pilloried by a small but vocal cadre of short-sighted community activists." Most of these activists were African Americans who had battled segregation years ago. "They saw a small alternative school as a ruse to bring back segregation," Hopkins said. The school board, unnerved, shelved the recommendation.

Over the past two weeks, teachers at T.C. have been angrier than I have ever seen them. We are angry at federal officials who label those of us who work in the most challenging schools as failures. We are angry at administrators who constantly send us mixed messages (be rigorous, but don't give out many Ds and Fs, and make sure everyone graduates!). We are angry that our leadership has been so unstable (the new principal to be named soon will be our third in five years).

And we are outraged that the school system enrolls newly arrived 18- to 20-year-old immigrants in the general student population, where they aren't in programs tailored to their particular needs. Had we done as Arlington and Fairfax counties do and offered them enrollment in an adult education program, their Standards of Learning scores would not have counted, and it's very unlikely that T.C. would have gotten the "persistently low achieving" label. We would also be serving those students better.

But the teachers also realize that we earned this label. For 39 years, I've been teaching grammar, writing and literature. Yet if a student comes into my classroom reading well below grade level, I don't know how to teach him to read. I should have taken courses years ago; I just never thought that I would need to teach reading in the 12th grade. And teachers

throughout the school system have passed kids on to the next grade, even though they have not mastered the skills they need to succeed at the next level.

Now that we've earned a label no one wants, maybe we'll be ready to label other things more accurately. Even students can identify the key challenges more clearly than many educators. "If T.C. wants to see any improvement, it will need a principal who will stick around and be willing to make unpopular decisions and confront head-on issues involving race -- which are really issues of economic class," said senior Luke Dorris, who has gained early admission to Columbia University.

The students also realize what's at stake. Tenth-grader Layla Mustafa said she is hearing a lot of kids say that their parents are thinking about taking them out of T.C. and sending them to private schools. "There are a lot of smart, hardworking kids here who are getting a great education, but with the state calling us 'persistently low achieving,' people outside of the school won't believe that," she said.

I'm confident we can shed our unwanted label. We took a great first step Tuesday night at a dinner that Superintendent Sherman hosted for all the T.C. staff members. Some, fearful that he would announce numerous firings, were calling it "the last supper." I thought it turned out to be Sherman's finest hour. He defended us and our work and told us he would probably exercise the least punitive option available to him: the "transformation model," which requires that we submit a detailed plan for improvement. He then opened the floor for the most honest discussion I have heard in all my years at the school.

One by one, teachers walked up to two microphones and addressed the problems -- and solutions -- they saw at T.C.: the lack of clear, consistent discipline; kids roaming the halls freely during class; the failure to curb cellphone and iPod use; the need to identify and focus on those students who are woefully behind in reading and math.

I couldn't help but chuckle when Steve Geter, a 27-year-old history teacher who didn't exactly kill himself studying when he was in my English class 10 years ago, suggested, to thunderous applause, that we could help change the atmosphere by making students wear uniforms. It seemed to be the first time that everyone was pulling in the same direction to confront the problems that helped give us the label we all hate.

I thought T.C. Williams being tagged "persistently low achieving" was the lowest moment of my career at this school. Now I see it more as an unfriendly wake-up call, something to pull us back from the long, slow slide of not serving all our students well.

Labels can be unfair. They never tell the whole story. But though we never wanted to achieve our new label, I have no doubt that it will help us get back to achieving our best.

But in 1997 the school board rejected a task force recommendation that Alexandria create an alternative school -- the type of school that we desperately need today to serve students with specific educational challenges. Glenn Hopkins, who runs a nationally recognized local preschool program, remembers that fight. He said he and other task force members were "pilloried by a small but vocal cadre of short-sighted community activists." Most of these activists were African Americans who had battled segregation years ago. "They saw a small alternative school as a ruse to bring back segregation," Hopkins said. The school board, unnerved, shelved the recommendation.

Over the past two weeks, teachers at T.C. have been angrier than I have ever seen them. We are angry at federal officials who label those of us who work in the most challenging schools as failures. We are angry at administrators who constantly send us mixed messages (be rigorous, but don't give out many Ds and Fs, and make sure everyone graduates!). We are angry that our leadership has been so unstable (the new principal to be named soon will be our third in five years).

And we are outraged that the school system enrolls newly arrived 18- to 20-year-old immigrants in the general student population, where they aren't in programs tailored to their particular needs. Had we done as Arlington and Fairfax counties do and offered them enrollment in an adult education program, their Standards of Learning scores would not have counted, and it's very unlikely that T.C. would have gotten the "persistently low achieving" label. We would also be serving those students better.

But the teachers also realize that we earned this label. For 39 years, I've been teaching grammar, writing and literature. Yet if a student comes into my classroom reading well below grade level, I don't know how to teach him to read. I should have taken courses years ago; I just never thought that I would need to teach reading in the 12th grade. And teachers throughout the school system have passed kids on to the next grade, even though they have not mastered the skills they need to succeed at the next level.

Now that we've earned a label no one wants, maybe we'll be ready to label other things more accurately. Even students can identify the key challenges more clearly than many educators. "If T.C. wants to see any improvement, it will need a principal who will stick around and be willing to make unpopular decisions and confront head-on issues involving race -- which are really issues of economic class," said senior Luke Dorris, who has gained early admission to Columbia University.

The students also realize what's at stake. Tenth-grader Layla Mustafa said she is hearing a lot of kids say that their parents are thinking about taking them out of T.C. and sending them to private schools. "There are a lot of smart, hard-working kids here who are getting a great education, but with the state calling us 'persistently low achieving,' people outside of the school won't believe that," she said.

I'm confident we can shed our unwanted label. We took a great first step Tuesday night at a dinner that Superintendent Sherman hosted for all the T.C. staff members. Some, fearful that he would announce numerous firings, were calling it "the last supper." I thought it turned out to be Sherman's finest hour. He defended us and our work and told us he would probably exercise the least punitive option available to him: the "transformation model," which requires that we submit a detailed plan for improvement. He then opened the floor for the most honest discussion I have heard in all my years at the school.

One by one, teachers walked up to two microphones and addressed the problems -- and solutions -- they saw at T.C.: the lack of clear, consistent discipline; kids roaming the halls freely during class; the failure to curb cellphone and iPod use; the need to identify and focus on those students who are woefully behind in reading and math.

I couldn't help but chuckle when Steve Geter, a 27-year-old history teacher who didn't exactly kill himself studying when he was in my English class 10 years ago, suggested, to thunderous applause, that we could help change the atmosphere by making students wear uniforms. It seemed to be the first time that everyone was pulling in the same direction to confront the problems that helped give us the label we all hate.

I thought T.C. Williams being tagged "persistently low achieving" was the lowest moment of my career at this school. Now I see it more as an unfriendly wake-up call, something to pull us back from the long, slow slide of not serving all our students well.

Labels can be unfair. They never tell the whole story. But though we never wanted to achieve our new label, I have no doubt that it will help us get back to achieving our best.

At T.C. Williams High School, a 'low achieving' label is a wake-up call

Things around T.C. Williams High School in Alexandria, where I teach English, have gotten pretty gloomy.

Two weeks ago, Superintendent Morton Sherman called an emergency faculty meeting. We gathered in the school auditorium to hear him break the news: Ours was officially a "persistently low achieving" school. That unflattering label is a new one, created by state officials and Education Secretary Arne Duncan for high schools ranked in the lowest 5 percent of schools statewide with demographics similar to ours.

I was stunned. Some of my seniors from last year went on to Yale, MIT, the University of Chicago and other great schools. Just that morning I had listened to my current seniors discuss Cormac McCarthy's "All the Pretty Horses," a novel that is hardly fare for underachievers. How dare some bureaucrats tag us with such a demeaning label?

Yet I couldn't hide from the facts: Based on students' scores over the past two years on the Virginia Standards of Learning tests, T.C. was ranked 122 of the 128 high schools in the state that serve a number of at-risk students but do not accept federal Title 1 resources. "Persistently low achieving" wasn't just another education cliche. Our scores didn't lie.

Things only got worse when Sherman told the teachers that we had four options for corrective action, three of which would probably involve firing at least half of us.

From that afternoon on, low-grade paranoia filled the school. We weren't just afraid of losing our jobs; the way we thought about T.C. had changed. Math teacher Gary Thomas got a call from his brother-in-law asking what it was like to teach at one of "the worst schools in the nation." Thomas is a West Point graduate and retired Army colonel who usually can be found in his classroom an hour before and an hour after school, tutoring kids. "You feel horrible when you are putting in the time and effort and see a lot of your students who catch on and do well get characterized as low achievers," he told me.

How did our school -- which in 1984 received one of the country's first Department of Education excellence awards and in 1988 had the highest number of National Merit semifinalists in the state -- get to this point?

T.C. Williams has always been proud of its student achievement and its diverse community. But as the demographics of the school shifted over the past 25 years and low-income students -- many of them minorities and immigrants -- began to outnumber middle-class kids, one thing that didn't change was the way the school thought about its

students. Even though we knew better, many of us -- both teachers and administrators -- acted as if all our students came to school with basic reading and math skills and had a parent at home actively supervising their education. The stragglers could do the work, we insisted, if they were in a room full of other kids who could do the work, too. The school definitely did not want to create tracking classes, in which kids are separated according to ability, or anything that could resemble ethnic or class-based segregation.

Instead of zeroing in on the relatively small number of students who came to us unprepared and needed a great deal of help to catch up, we opted for appearances. The school mixed kids of different academic levels into the same classes in hopes that the best students would pull up those on the bottom. We also continued passing kids through the system, whether they had learned the skills they needed or not. Gary Thomas says many students enter T.C. Williams not knowing how to add or subtract without a calculator, and even the better students do not understand fractions.

We tried to confront some of these challenges once before. But in 1997 the school board rejected a task force recommendation that Alexandria create an alternative school -- the type of school that we desperately need today to serve students with specific educational challenges. I am writing to let you know that Burke Branch Friends of the Burke Branch

Library emphatically oppose any rejection of the pending project that would

install a "green roof" on the Library's building. I testified

before the Mayor and Council on November 21, 2009 alongside Members of the

Library Board to urge against further cuts in the Library's budget. Thus

we share Brooksie Hoopman's, the Library Board Chair's, very genuine and

serious concerns about the state and fate of the library's resources.

However, we strongly disagree with her rejection of the project as waste of the City's resources. We reject the position for several reasons. Briefly --

1. The position is premised on a factually incorrect

premise; namely, that the current roof is sound and secure. Burke Library

staff can tell you that the roof has leaked and been repaired for such

problems. Second, the roof continues to leak in the Young Adult section.

Moreover, to the extent that extreme climate and temperature variations in the library are due in whole or part to the current impervious roof, the green roof should help alleviate the resulting adverse conditions for employees and patrons alike.

- 2. The position appears to be premised on the hope, if not the belief, that the Mayor and Council can convert the matching funds set aside in the capital budget to the City's and thus the Library's operational budget. Short, of a total economic collapse, we doubt that the elected leadership will or should invade the capital budget to effectuate any restoration of the extremely unfortunate and regrettable cuts in the Library's operations. (We are no experts, but it may not even be legally possible.)
- 3. Given points 1 and 2 above, which appear to be at heart of the opposition to install the green roof, we believe the position has no clear rational or convincing basis for upending a "go forward" decision the Mayor and Council made on September 22, 2009. Unfortunately, though an understandable cry for budget relief for Library operations, the position can and will be interpreted by those in some quarters to be aimed at thwarting environmental progress. The City's Eco-Charter and its Eco-Action Plan project the eventual retrofitting of all city building roofs to stem water pollution and its effects. The current general economic strife can't and shouldn't be legitimately used as an accepted or acceptable rationale for putting off -- actually cancelling -- a project such as this when both the EPA funds and the requisite city matching had already been set aside.

Comments:

4. It is

regrettable that the Library Board did not receive a timely "heads up" from the Department of Transportation and Enviornmental Services on its plans. However, mistakes or neglect in communications between city agencies should not deprive the Burke community residents and its Library of the benefits and equities inherent in the latest in environmental

developments. We are mindful that the Duncan Library Branch has a green roof. We believe Burke should be permitted to join the environmental mainstream.

5. We are also mindful that Congressman Moran worked to ensure that the City of Alexandria receive the general EPA grant several years ago and that EPA itself expects a project to be launched in Alexandria, which addresses pollution issues related to the Four Mile Run watershed. The City has greatly relied on its staff experts at the Department of Transportation and Environmental Services to acquire and "grow" its reputation as one of the environmentally progressive urban areas in the country. These same experts chose the Burke Branch Library for sound reasons. The Mayor and Council Members should reaffirm their support of this Project and perhaps direct the Department to ensure that it "covers its inter-agency comunication bases" in the future.

We will send a written presentation further elaborating the
Friends' position on the Green Roof question no later tham April 2. We
just learned last week of the details of the Board Chair's testimony on
March 10 and her additional comments at the March 24 budget working session
or we would have commented sooner. We are sorry that we disagree with an
acknowledged champion of the Library whom I joined, as I said above, in
testifying against cutting the Library's budget. But in this instance, we
must depart from the Chair and a position that we believe harms the
interests of the Burke community and its LIbrary and does not advance the
interests of the Library as a whole.
