



in Bethesda. I am encouraged about my longterm prognosis and I continue on

with my life in the face of such adversity, I still have much left to

accomplish and many more people to help. I have
no bones about admitting

my status my only concern is that the nature of ignorance and fear being

what it
is that some could use this information about me to less than

constructive ends but I can't be too
concerned about this now. I owe so

much to my family, my friends and to the people of this great City of

Alexandria. I try everyday to make amends for my previous mis-steps in

life, and I hope that the Council
will favorably consider my appointment

to the Alexandria Community Service Board. I hope to see you all
before

the start of Council business on Tuesday, April 27, 2010.
