RESOLUTION TO ADOPT FEE INCREASES FOR THE DEPARTMENT OF

RECREATION, PARKS AND CULTURAL ACTIVITIES FOR FISCAL YEAR

2011

<u>ISSUE</u>: Resolution to increase cost recovery through fee increases for the Department of Recreation, Parks and Cultural Activities (RPCA) programs as adopted in the FY 2011 approved budget.

**RECOMMENDATION**: That Council adopt the proposed resolution (Attachment 1) for the recommended fee increases (Attachment 2) of Field Rental Fees, Garden Plot Rental Fees, Adult Fitness Fees, Youth Sports Registration Fees and Youth Sports Field Use Fees, effective July 1, 2010.

**BACKGROUND**: The Department of Recreation, Parks and Cultural Activities regularly adjusts program and activity fees that include, classes, camps, workshops and other programs as needed in order to stay in line with market trends and cost recovery efforts. As part of the FY 2008 budget process, Council provided the City Manager the authority to adjust RPCA non-programmatic fees annually, with a maximum increase equal to the annual rate of inflation (CPIU). Within this authority, the actual fee may be rounded to an administratively convenient amount to assume efficient assessment and collection of fees. Increases in fees exceeding this amount continue to be considered by Council. No fee increases based on the CPI-U were recommended in the adopted FY 2011 approved budget.

**DISCUSSION**: As part of the FY 2011 budget, RPCA staff did not recommend fee changes for non-programmatic fees based on an inflation rate (CPI -U) using the above mentioned authority. The inflation rate, estimated at 2%, would have generated negligible revenue increases, but staff will account for these fee increases in future fee recommendations. Five other fee categories fell outside of the authority previously delegated to the City Manager. The proposed increases in those five fee areas are above the CPI-U.

In summary and to highlight significant changes, the attached Resolution provides:

- To increase the hourly rate for Athletic Field Rentals by \$10 per hour in order to help offset the cost of park maintenance operations and as specified in Attachment 2;
- To increase Full Size Garden Plot Rentals by \$10 per year in order to help offset the cost of park maintenance operations as specified in Attachment 2;
- To establish an Adult Fitness Fee for adults to the use the fitness rooms at the Nannie J. Lee, William Ramsay, Charles Houston, and Cora Kelly Recreation Centers as specified in Attachment 2;
- To increase the Youth Sports Registration Fee by \$5 per sport for youth sports leagues and programs managed by the City as specified in Attachment 2; and
- To increase the Youth Sports Field Use Fee by \$5 per registrant per season for field use by non-City managed youth sports leagues (i.e. Alexandria Soccer, Little League, and Lacrosse).

All FY 2011 RPCA fees will be available on the City's fee consortium for public information.

In addition, the RPCA section of the City's website will post information to notify people's attention to all fee changes that are scheduled to occur.

**FISCAL IMPACT**: The FY 2011 Approved Budget includes an increase of \$80,640 in General Fund revenues in anticipation of these RPCA fee changes.
