RESOLUTION AFFIRMING LOCAL EMERGENCY DECLARATION FOR

DECEMBER SNOW STORM

ISSUE: Resolution affirming Local Emergency Declaration for December Snow Storm

RECOMMENDATION: That City Council adopt the attached resolution (Attachment 1).

<u>DISCUSSION</u>: As a result of the record breaking snow storm that hit Alexandria last weekend (beginning on Friday, December 18,) on Saturday, December 19, I issued a Local Declaration of Emergency (Attachment 2) so that the City was positioned to take advantage of any state or federal assistance that might become available. I extended the expiration date of the declaration from December 22 to 12:01 a.m. on December 24, (Attachment 3) due to the extensive snow removal effort that was required to address the 17 to 20 inches of snow that we received in Alexandria.

State law and the City Code require that City Council affirm my Local Emergency Declaration within 14 days. We have contacted all of the members of City Council, and everyone is available to attend the December 29 special meeting.

I recommend that Council adopt the resolution.

DECLARATION OF LOCAL EMERGENCY CITY OF ALEXANDRIA, VIRGINIA

WHEREAS, the Director of Emergency Management of the City of Alexandria, Virginia finds that, due to the historic snowfall, the City continues to face emergency conditions that imperil life and property of sufficient severity and magnitude to threaten or constitute an emergency; and

WHEREAS, to necessitate this declaration of the existence of a local emergency, the December 18, 2009, Winter Storm was the largest snowfall for several years in the National Capital Region; and

WHEREAS, Emergency Services continue to be hampered due to the road conditions, staff has been engaged in snow operations round-the-clock for over three days, some roads are still impassable, the critical infrastructure such as power, telephone, water, waste water and other key resources of the City as well as the region may be severely impacted, food and water are scarce, there is the potential for building collapse, major power outages or other emergencies, and opening emergency sheltering; now

THEREFORE, IT IS HEREBY DECLARED, that a local emergency exists throughout the City of Alexandria; and

IT IS FURTHER DECLARED AND ORDERED, that during the existence of said emergency, the powers, functions and duties of the Director of Emergency Management shall be those prescribed by state law and the ordinances, resolutions and operations plans of the City of Alexandria, and that any actions taken under this declaration shall be directed at the prevention or mitigation of damage, loss, hardship or suffering threatened by, or resulting from, the emergency.

The original declaration was effective December 19, 2009 and is hereby extended and; This declaration shall expire at 12:01 a.m., Thursday, December 24, 2009, unless extended or sooner terminated by the Director of Emergency Management in writing.

DECLARATION OF LOCAL EMERGENCY CITY OF ALEXANDRIA, VIRGINIA

WHEREAS, the Director of Emergency Management of the City of Alexandria, Virginia finds that, due to the historic snowfall, the City faces emergency conditions that are potentially of peril to life and property of sufficient severity and magnitude to threaten or constitute an emergency and therefore, to necessitate this declaration of the existence of a local emergency; the December 18, 2009 Winter Storm, will be the largest snowfall during December in the National Capital Region, roads and bridges may be closed, the critical infrastructure such as power, telephone, water, waste water and other key resources of the City as well as the region may be severely impacted, food and water is scarce, there is the potential for building collapse, major power outages or other emergency, opening emergency sheltering might be necessary. Response is hampered due to the road conditions and staff has been engaged in snow operations for over 15 hours already.

NOW, THEREFORE, IT IS HEREBY DECLARED, that a local emergency exists throughout the City of Alexandria, and

IT IS FURTHER DECLARED AND ORDERED, that during the existence of said emergency, the powers, functions and duties of the Director of Emergency Management shall be those prescribed by state law and the ordinances, resolutions and operations plans of the City of Alexandria, and that any actions taken under this declaration shall be directed at the prevention or mitigation of damage, loss, hardship or suffering threatened by, or resulting from, the emergency

This declaration is effective December 19, 2009

This declaration shall expire at 12:01 a.m., Tuesday, December 22, 2009, unless extended or sooner terminated by the Director of Emergency Management in writing.
