Support our initiative to create a new waterfront plan, based on what Alexandria does best: ***History, Arts and Culture***

We aim to ***enlist citizens*** in crafting a plan based on what ***they*** want and not on what the city is proposing which is: Building 3 hotels with 625 hotel rooms, and increasing the density by raising the FAR (floor area ratio).

The city says we need to build hotels to generate revenue and has based their plan on commercial development. Alternatives to this economic model have never been explored or developed. ***We will present an alternative Vision, including creating an arts district.***

We will propose ***alternative economic models*** to achieve the goals of a vibrant, open and accessible waterfront that we all want ***without dependence on commercial development.***

The city has not included protections for all the historic structures identified by the Office of Historic Alexandria. ***We will craft a plan that identifies, protects and maintains historic buildings and requires a historic structure report as opposed to opinion.***

The city has not made any guarantee that we will maintain our creative cultural institutions like The Seaport Foundation and the Art League, or create room for new non-profits. The city has also not looked at the contribution made by the Torpedo Factory Art Center to revitalizing the waterfront, and used that as a model for future development. ***We will make sure there is a home for boatbuilding and artists on our waterfront, and that the economic value of cultural institutions are weighed equally with commercial development.***

We believe it is time for an ***Alexandria Seaport Museum, and we will make sure this plan designates a location for that museum. We would like to see West's Point (Robinson Terminal North) designated as this site. A visitors center/bookstore can be located in the two old mill buildings on Union.***

We appreciate the hard work and the contributions citizens and staff have made to the proposed plan, but it is based on the wrong assumptions. We also appreciate the work of historians and artists to add important elements to this plan and we want to make sure that ***the arts walk and history plans are fully funded and incorporated into the final plan.***
