BAR Meeting November 3, 2004

**ISSUE:** Shutters

**APPLICANT:** David Lamb & Sandra Northrop

**LOCATION:** 312 North Columbus Street

**ZONE:** RB/Residential

**BOARD ACTION, OCTOBER 20, 2004**: On a motion by Mr. Wheeler, seconded by Ms. Neihardt the Board deferred the application for restudy. The vote on the motion was 5-0.

**REASON**: The Board wanted additional information regarding the shutters that had been installed at 310 North Columbus Street. The Board noted that these were paired houses and should be treated as such regarding the shutters.

SPEAKER: David Lamb, homeowner, spoke in support

#### **UPDATE**:

Since the last public hearing, Staff has conducted additional research to determine if shutters were ever approved at 310 North Columbus Street. Staff was unable to locate any evidence of the Board having approved shutters for either 310 or 312 North Columbus Street. Therefore, Staff repeats the recommendation from the October 6, 2004 staff report.

## **STAFF RECOMMENDATION**:

Staff recommends denial of the application and that the installed shutters be removed within 30 days of the date of this hearing.

#### I. ISSUE:

The applicant is requesting approval of a Certificate of Appropriateness to add shutters to the property at 312 North Columbus Street. The wood louvered shutters are proposed to match the existing shutters at 310 North Columbus Street.

#### II. HISTORY:

312 N Columbus Street is a two story three bay semi-detached Victorian rowhouse constructed between 1902 and 1907.

In 1990, the Board approved alterations to the rear facade (BAR Case #90-134, 7/18/90). The Board approved rear additions in 1982 and 1970 (10/6/82, 10/17/79). In 1965, the Board approved the replacement of the rear wood stairway with steel (1/13/65).

In 1999, the Board approved painting the side elevation of the adjoining house at 310 North Columbus Street (BAR Case #99-0208, 12/1/99). Staff notes that the existing shutters at 310 North Columbus Street were installed subsequent to the 1999 approval and were not approved by the Board. In 1970, the Board approved an application to enclose the rear porch at 310 North Columbus Street (11/4/70).

### III. ANALYSIS:

While posting the subject property with the notice of public hearing, Staff discovered that the shutters were in the process of being installed. The contractor was notified by Staff that the shutters were scheduled for a public hearing and must be approved by the Board before installation could be completed.

Staff has a number of concerns with the proposed application. Staff believes that the shutters are inappropriate. This is an early 20<sup>th</sup> century house with a pressed brick front. As such, the front of the house was meant to showcase the technological improvements that had been made in the manufacture of brick. Thus the brick front was meant to be seen as a whole and not partially covered by wood shutters.

The *Design Guidelines* state that "window and door shutters should be appropriate to the period of the structure. For example, shutters were not part of the original design vocabulary for several Victorian and early 20<sup>th</sup> century architectural styles (Shutters - Page 1). The *Design Guidelines* further state that "shutters should not be added to a structure in an attempt to make the structure

appear older than it actually is" (Shutters - Page 2).

Shutters approved by the Board are required to fit the size of the opening. Staff notes that there is not sufficient space for a shutter on the second story window above the entrance. As seen on the neighboring building, a shutter at this location would overlap and extend beyond the property line.

Although the shutters are proposed to be wood, hinged and operable as specified in the *Design Guidelines*, Staff does not believe that they are appropriate for this building.

# **IV. STAFF RECOMMENDATION**:

Therefore, Staff recommends denial of the application and that the installed shutters be removed within 30 days of the date of this public hearing.
